- 1. One Grievance is at Step 1. Resolution is immanent.
- 2. Nurses hired without a Masters degree and studying towards one at Management's encouragement are wondering who pays for the required textbooks, and who pays travel expenses to Sudbury? The College is willing to

- settle in favour of the Grievor(s).
- 3. Step Calculations. Don't receive a Step for each year completed, but receive a Step for completion of entire degree. Degree must be physically in hand. College is not providing Step Calculations to the Union. This will be a UCC Item.

8.0 Reports of Committees:

8.1 WMG

Two staff members are working on a project to involve/train (?) Union members regarding new technologies at the College. The Local will request a meeting with Management and the project staff members to find out the implications of such work.

8.2 CESC

A joint CESC meeting will be held on Wed., Sept 24/'03 at the Porcupine Campus.

8.3 UCC

The College wants to know what the Local feels about hiring back members who have retired. Discussion ensued. The Chief Steward was seeking direction from the LEC. It seems the LEC agrees, Management can hire back a retired person as long as the intended purpose is not to erode the "floor of 80" and replace full time bargaining position(s) with part time, partial load, and sessional.

Evaluation Tool for Faculty. Management wants to evaluate Faculty. Management is seeking input from the Union as to how the Evaluation will take place. The unanimous consensus among the LEC is to let Management construct their own Evaluation and then submit it to the LEC for review.

8.4 H&S

Haileybury Health and Safety Rep. received Basic Certification training.

8.6 IT

Things are going well. CITRIX is working well. Blackboard is being upgraded. Members need to be trained in the new technologies. This will be a WMG Item.

10. New Business:

10.1 The President distributed Handout "Working Document" (Secretarial File)

This document provides a summary of Management's Position

and Union position regarding various negotiation items. A strike is a possibility. The OPSEU does not want the strike between October and December. OPSEU does not want its members on the picket line in the cold, and prior to Oct. 03/'03 there is no sitting government waiting to listen to Union concerns. A probable strike vote could be held in Feb./'04. The President tabled a proposed salary grid "14.03 A 1 (a) (Secretarial File).

- 10.2 The Chief Steward spoke about his eventual replacement.

 He indicated the need to train someone for the Chief Steward's position.

 He would like to have a member "shadow" him for a lengthy period of time with the approval of Management. It will be a costly proposition. Further information to come.
- 10.3 President tabled a memo dated August 28/'03, Subject: Joining CAUT. CAAT (Academic) Division wants closer ties with CAUT, the Canadian Association of University Teachers. This Association will not cost the Local any money.
