- c. Article 11.05. Unreasonable teaching Load for Nursing Faculty in Porc. Issue resolved.
- d. Blackboard. Memo will be sent by H.R. out in late August/'06 indicating Faculty's responsibility regarding College's expectations for Fall/'06.
- e. Spring SWFs Kirkland Lake. SWFs issued without prior consultation. Union asks that Spring SWFs/'06 be reissued in line with Collective Agreement.
- e. Promotion Meetings in Kirkland Lake. Because of Strike, Promotion Meetings are in limbo. Return to Work Union Policy may be invoked regarding extra compensation.

f. Discover Northern. Because of Strike, this day has been scheduled on April 29/'06 outside the SWF period thus "atypical". An agreement had been negotiated last year to deal with such "days" but within the SWF period.
