- 10.3 Coordinator Positions. Much discussion ensued regarding the College's distribution of a Memo addressed to all Coordinators effectively telling them their Coordinator positions will be terminated. Many Coordinators expressed frustration and wonder at the College's move.

 The Union's response is to file three Grievances. One is a Group Grievance.

Not enough notice was given to Faculty. The second Grievance is a Union Grievance requesting description of Coordinator duties. And the third Grievance involves failure of the College to comply with Article 1.01.

10.4 Modified Workload Agreement. The Porc Nursing Faculty are accustomed to doing their clinical duties all in one day at the hospital. The work day length (beyond 8 hrs/day) contravenes Article 11.01 L 1. The LEC tried to reach a resolution. Discussion ensued.

The final consensus was that the LEC will attempt to present a Local Agreement to Management. It was understood by all that all College Local Agreements must be fettered by OPSEU head office.
