#### 1. Call to Order

This meeting was convened for faculty to receive information from the Bargaining Team with regards to the state of bargaining for the next CAAT-Academic Collective Agreement, by way of a presentation from Ravi Ramkissoonsingh (Niagara College, member of the Bargaining Team). As such, this information presentation was the only agenda item.

#### 3. New Business

**3.1 Guest Speaker:** Ravi Ramkissoonsingh (Niagara College, member of the Bargaining Team)

Mr. Ramkissoonsingh shared that bargaining started in July 2017 and there have been 9 days of meetings with regards to bargaining. The Bargaining Team has presented issues that were described by Mr. Ramkissoonsingh. Management has not been bargaining with the union, but presented an offer for settlement. The terms of this offer are very poor for faculty. A new proposal was submitted by the union in August 2017, and Mr. Ramkissoonsingh provided some information on that new proposal. Mr. Ramkissoonsingh provided information on management's response to the new proposal: unacceptable alternate proposals and then a relaunch of basically the same offer as previous.

Mr. Ramkissoonsingh presented a more detailed breakdown of specific items and information raised by the union, and the very brief, very incomplete, unacceptable responses received for each.

Mr. Ramkissoonsingh provided information on the context and potential next interactions that might occur with regards to bargaining.
